Nevada Gaming Revenues and Collections

Win Revenue Summary – October 2007

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,164,875,043 for the month of October 2007. This amounts to a 9.61% <u>increase</u> compared to October 2006, when licensees reported a gaming win of \$1,062,743,303. For the fiscal year (July 1, 2007 through October 31, 2007), gaming win has increased 5.67%.

Percentage Fee Collections for the Month of November 2007

The State collected \$71,870,167 in percentage fees during the month of November 2007, based upon the taxable revenues generated in October 2007. This represents a 1.47% (or \$1,037,935) <u>increase</u> compared to the prior year's October, when percentage fee collections were \$70,832,232.
