Nevada Gaming Revenues and Collections

Win Revenue Summary – October 2018

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,062,795,796 for the month of October 2018. This amounts to a 7.47% increase compared to October 2017, when licensees reported a gaming win of \$988,966,026. For the fiscal year (July 1, 2018 through October 31, 2018), gaming win has increased 0.17%.

Percentage Fee Collections for the Month of November 2018

The State collected \$56,916,239 in percentage fees during the month of November 2018*, based upon the taxable revenues generated in October 2018. This represents a 4.65% (or \$2,774,153) decrease compared to the prior year's November, when percentage fee collections were \$59,690,392.
