#### **Nevada Gaming Revenues and Collections**

# Win Revenue Summary – October 2021

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,221,410,318 for the month of October 2021. This amounts to a 48.54% <u>increase</u> compared to October 2020, when licensees reported a gaming win of \$822,271,869. For the fiscal year (July 1, 2021 through October 31, 2021), gaming win has increased 56.05%.

# Percentage Fee Collections for the Month of November 2021

The State collected \$71,808,409 in percentage fees during the month of November 2021\*, based upon the taxable revenues generated in October 2021. This represents a 42.07% (or \$21,265,787) <u>increase</u> compared to the prior year's November, when percentage fee collections were \$50,542,622.
