October 1999 Nevada Gaming Revenues and Collections

Win Revenue Summary - October

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$794,455,891 for the month of October 1999. This amounts to a 6.20% <u>increase</u> compared to October 1998, when licensees reported a gaming win of \$748,044,991.

Percentage Fee Tax Collections for the Month of November 1999

The State collected \$49,268,329 in percentage fee taxes during the month of November 1999, based upon the taxable revenues generated in October 1999. This represents a 13.91% (or \$6,014,963) increase compared to the prior year's November (1998), when percentage fee collections were \$43,253,366.

On a five-month fiscal-year-to-date (July 1, 1999 through November 30, 1999), the State of Nevada collected \$226,311,029 in percentage fee taxes. This represents a 14.98% <u>increase</u> from the prior fiscal year five-month period when collections totaled \$196,823,682.
