September 2001 Nevada Gaming Revenues and Collections

Win Revenue Summary - September 2001

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$763,605,971 for the month of September 2001. This amounts to a 3.15% <u>decrease</u> compared to September 2000, when licensees reported a gaming win of \$788,407,130.

Percentage Fee Tax Collections for the Month of October 2001

The State collected \$45,851,615 in percentage fee taxes during the month of October 2001, based upon the taxable revenues generated in September 2001. This represents a 10.81% (or \$5,559,569) decrease compared to the prior year's October (2000), when percentage fee collections were \$51,411,184.

On a four-month fiscal-year-to-date (July 1, 2001 through October 31, 2001), the State of Nevada collected \$182,556,012 in percentage fee taxes. This represents a 2.11% <u>decrease</u> from the prior fiscal year four-month period when collections totaled \$186,494,060.
