## September 2002 Nevada Gaming Revenues and Collections

### Win Revenue Summary – September 2002

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$810,138,462 for the month of September 2002. This amounts to a 6.08% <u>increase</u> compared to September 2001, when licensees reported a gaming win of \$763,690,200.

## Percentage Fee Tax Collections for the Month of October 2002

The State collected \$55,153,573 in percentage fee taxes during the month of October 2002, based upon the taxable revenues generated in September 2002. This represents a 20.29% (or \$9,301,958) <u>increase</u> compared to the prior year's October (2001), when percentage fee collections were \$45,851,615.

On a four-month fiscal-year-to-date (July 1, 2002 through October 31, 2002), the State of Nevada collected \$184,525,235 in percentage fee taxes. This represents a 1.08% <u>increase</u> from the prior fiscal year four-month period when collections totaled \$182,556,012.

### **Comments from the Governor**

"Despite the encouraging 6 percent increase in gaming win over last September, we are still nearly \$17 million short of gaming tax revenue as projected by the Economic Forum for fiscal year 2003. This follows a \$31 million shortfall in fiscal year 2002."

"We were quite confident we would have a good month this September compared to September 2001, which of course included the downturn in visitors following the tragedy of 9/11. However, to put the September 2002 revenue picture into perspective, year-to-date gaming tax collections are actually about \$2 million short of where they were during the first four months of fiscal year 2001."
