Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2011

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$863,949,250 for the month of September 2011. This amounts to a 5.87% <u>decrease</u> compared to September 2010, when licensees reported a gaming win of \$917,861,844.

Percentage Fee Collections for the Month of October 2011

The State collected \$51,435,071 in percentage fees during the month of October 2011, based upon the taxable revenues generated in September 2011. This represents an 8.89% (or \$5,019,920) decrease compared to the prior year's October, when percentage fee collections were \$56,454,991.
