Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2012

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$892,748,756 for the month of September 2012. This amounts to a 3.33% <u>increase</u> compared to September 2011, when licensees reported a gaming win of \$863,971,309. For the fiscal year (July 1, 2012 through September 30, 2012), gaming win has increased 5.63%.

Percentage Fee Collections for the Month of October 2012

The State collected \$71,078,162 in percentage fees during the month of October 2012, based upon the taxable revenues generated in September 2012. This represents a 38.19% (or \$19,643,091) <u>increase</u> compared to the prior year's October, when percentage fee collections were \$51,435,071.
