Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2014

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$901,697,989 for the month of September 2014. This amounts to a 5.96% decrease compared to September 2013, when licensees reported a gaming win of \$958,894,854. For the fiscal year (July 1, 2014 through September 30, 2014), gaming win has decreased 3.03%.

Percentage Fee Collections for the Month of October 2014

The State collected \$65,876,536 in percentage fees during the month of October 2014*, based upon the taxable revenues generated in September 2014. This represents a 4.57% (or \$2,878,953) increase compared to the prior year's October, when percentage fee collections were \$62,997,583.
