Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2015

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$916,350,471 for the month of September 2015. This amounts to a 1.52% <u>increase</u> compared to September 2014, when licensees reported a gaming win of \$902,607,141. For the fiscal year (July 1, 2015 through September 30, 2015), gaming win has decreased 0.29%.

Percentage Fee Collections for the Month of October 2015

The State collected \$58,076,314 in percentage fees during the month of October 2015*, based upon the taxable revenues generated in September 2015. This represents a 12.22% (or \$8,082,002) <u>decrease</u> compared to the prior year's October, when percentage fee collections were \$66,158,316.
