Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2016

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$948,961,678 for the month of September 2016. This amounts to a 3.55% increase compared to September 2015, when licensees reported a gaming win of \$916,466,663. For the fiscal year (July 1, 2016 through September 30, 2016), gaming win has increased 2.84%.

Percentage Fee Collections for the Month of October 2016

The State collected \$63,397,593 in percentage fees during the month of October 2016*, based upon the taxable revenues generated in September 2016. This represents a 9.13% (or \$5,302,219) increase compared to the prior year's October, when percentage fee collections were \$58,095,374.
