Win Revenue Summary – September 2018

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$991,222,034 for the month of September 2018. This amounts to a 1.26% <u>increase</u> compared to September 2017, when licensees reported a gaming win of \$978,932,772. For the fiscal year (July 1, 2018 through September 30, 2018), gaming win has decreased 2.26%.

Percentage Fee Collections for the Month of October 2018

The State collected \$54,497,722 in percentage fees during the month of October 2018*, based upon the taxable revenues generated in September 2018. This represents a 7.62% (or \$4,493,689) decrease compared to the prior year's October, when percentage fee collections were \$58,991,411.
