Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2021

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,158,168,180 for the month of September 2021. This amounts to a 41.07% increase compared to September 2020, when licensees reported a gaming win of \$820,980,906. For the fiscal year (July 1, 2021 through September 30, 2021), gaming win has increased 58.71%.

Percentage Fee Collections for the Month of October 2021

The State collected \$72,916,279 in percentage fees during the month of October 2021*, based upon the taxable revenues generated in September 2021. This represents a 7.50% (or \$5,089,820) increase compared to the prior year's October, when percentage fee collections were \$67,826,459.
