Good morning. Aira Mae Duyanen for the Culinary Union.

My comments concern the Rampart Casino at the Resort at Summerlin and the gaming license of Shirazalli Jafferli Lalji, who died March 28, 2020, but was listed as having an active gaming license until March 21, 2024.

Mr. Lalji was listed as an active beneficiary and director within the ownership structure of the Rampart Casino, according to a Nevada Gaming Control Board location details report for the property for March 15, 2024.

On March 21, we gave public comment to the Nevada Gaming Commission about Mr. Lalji, asking the Commission for clarification on whether Mr. Lalji should be removed.

That day the Nevada Gaming Control Board changed Mr. Lalji's status, as shown on the location details report, from "beneficiary and director" to "removed."

As of Monday April 1, the report lists Mr. Lalji as deceased within the casino's ownership structure, but continues to list him as "active."

Today we seek further clarification.

According to the Control Board report, Mr. Lalji died on March 28, 2020. His role as a "beneficiary" and "director" within the Rampart Casino ownership structure was marked "removed" on March 21, 2024.

We have two questions.

Why was a deceased Mr. Lalji listed as having a gaming license for almost four years after his death?

And why is a deceased Mr. Lalji still as of April 1, reported as active within the Rampart Casino ownership structure?

We request answers to these important questions. Thank you.

Good morning. Zachary Poppel for the Culinary Union.

Station Casinos, its parent company Red Rock Resorts Inc. and its properties face a series of National Labor Relations Board cases that together constitute one of the largest labor law enforcement actions in history.

Last week, on March 29th, a U.S. Administrative Law Judge issued an order setting the next hearing dates in an ongoing Unfair Labor Practice trial over a complaint issued in April 2021. In person hearings in Las Vegas will begin July 30th, 2024 and take place in Las Vegas that entire week through the end of the day on August 2, 2024.

We welcome this development. Station Casinos has a large footprint in the Las Vegas Valley and their shameful actions have a wide reach in our community. And we all suffer when bad actors and a publicly traded Nevada gaming company are not held accountable.

In April 2021 the NLRB's General Counsel alleged that Red Rock Resorts and 10 affiliated casino hotels in Las Vegas, engaged in a scheme to use employee layoffs during the COVID-19 pandemic to undermine unions representing or seeking to represent their employees. That trial will resume in July.

In the meantime, on Tuesday, April 12, 2022, an Administrative Law Judge issued a robust 138-page decision and proposed order requiring Station Casinos' Red Rock Casino to bargain with the Culinary and Bartenders Unions. This decision follows the injunction issued by the U.S. District Court and affirmed by the Ninth Circuit covering many of the same issues.

In his 2022 decision and proposed order, the Administrative Law Judge wrote: "Here, as fully discussed above, there is abundant evidence—both direct (e.g., the previous unlawful promise of such benefits, and other recorded statements, PowerPoints, emails, and text messages) and circumstantial (e.g., the suspicious and rushed timing and the false, evasive, and inconsistent testimony noted above regarding

Good morning. My name is Adam Christian. I work at Red Rock Casino, as a food server at T-Bones. I've worked there for 18 years. I'm a Union leader and I wear my Union button and organize everyday.

The former president of the United States, Donald Trump, was in T-Bones at Red Rock around July 7, 2023.

I was working that day at T-Bones. I saw Mr. Trump come into the restaurant. I saw people clapping. Someone near me shook Mr. Trump's hand. I saw Mr. Trump go into a private dining room.

I was scheduled to work in that private dining room that day. It's my section. It's my work. I am very good at my work and I'm an expert in private dining service.

I'm also pro-Union and have been fighting for a union contract at Red Rock for many years.

I believe I was denied work in the private dining room the day Mr. Trump was there because I am pro-Union. My employer put me on their MUD List as pro-Union.

What I and my coworkers want is simple and not complicated. We want respect. We want the discrimination to stop. And we want a contract now.
