Good morning. Jesus Landeros for the Culinary Union.

Station Casinos, its parent company Red Rock Resorts Inc. and its properties face a series of National Labor Relations Board cases that together constitute one of the largest labor law enforcement actions in history.

On March 29th a U.S. Administrative Law Judge issued an order setting the next hearing dates in an ongoing Unfair Labor Practice trial over a complaint issued in April 2021. In person hearings in Las Vegas will begin July 30th, 2024 and take place that entire week.

We welcome this development. Station Casinos has a large footprint in the Las Vegas Valley and their actions have a wide reach in our community.

In April 2021 the NLRB's General Counsel alleged that Red Rock Resorts and 10 affiliated casino hotels in Las Vegas, engaged in a scheme to use employee layoffs during the COVID-19 pandemic to undermine unions representing or seeking to represent their employees. That trial will resume in July.

In the meantime, on Tuesday, April 12, 2022, an ALJ issued a 138-page decision and proposed order requiring Station Casinos' Red Rock Casino to bargain with the Culinary and Bartenders Unions. This decision follows the injunction issued by the U.S. District Court and affirmed by the Ninth Circuit covering many of the same issues.

In his 2022 decision and proposed order, the ALJ wrote: "Here, as fully discussed above, there is abundant evidence—both direct (e.g., the previous unlawful promise of such benefits, and other recorded statements, PowerPoints, emails, and text messages) and circumstantial (e.g., the suspicious and rushed timing and the false, evasive, and inconsistent testimony noted above regarding the relevant facts and circumstances) —that the Company's motive for developing, approving, and ultimately announcing the new benefits and programs at the Red Rock on December 10 and 11 was to undermine

the Culinary Union campaign there. Indeed, it is hard to imagine a stronger evidentiary record supporting the General Counsel's and the Union's allegations." The NLRB in DC is now reviewing the ALJ's decision in response to Station Casino's request. We fully expect yet another victory from the NLRB soon.

We encourage the Board to examine the abundant evidence of company records and testimony. The facts and evidence, in our view, are on the side of the workers.

So, again, we welcome the resumption of hearings this summer and for the record want to insist that any Station Casinos gaming license holder who testifies under oath in those hearings needs to give credible testimony.

My name is José Raymundo Garcia. I have worked at Boulder Station for 8 years. I am a cook.

The reason why I want to have a union is to have the best benefits such as a pension and Culinary insurance. And because nothing is respected in our work area, such as the schedule and days off. Even the benefits are not equal in the company. We should all earn benefits equally.

Good morning. Rory Kuykendall here today for the Culinary Union.

I'm here today to ask for your attention to certain issues we have found regarding Virgin Las Vegas.

Specifically, I'm here to talk about JCLPF Vegas, LLC, which is the owner of Virgin Las Vegas Hotel according to the website of Juniper Capital, and one of Juniper Capital's managing partners, Jay Wolf, who is the chairman of the board of JCLPF Vegas, LLC, the owner of the Virgin Las Vegas Hotel.

Jay Wolf has been involved in many companies in a career that spans two decades. However, it is not clear whether he has ever been involved in an investment on the scale of the Virgin Las Vegas, which was purchased for \$500 million in 2018 and renovated for another \$200 million.

Jay Wolf worked at Trinad Capital Management LLC from 2003 to 2009. Trinad managed "an activist hedge fund primarily focused on distressed small-cap public companies."

From 2007, he was on the board of a company called Zoo Entertainment Inc., and he became executive chairman of the board in February, 2010. The video game company had market cap of approximately \$5.85 million and sales of \$63.5 million in 2011.

In 2020, Wolf was designated as a director of IMH Financial Corp, according to an SEC filing from April 29th of that year. In July 2020, WSJ reported that JP Morgan was to take over that company after it filed for Chapter 11 bankruptcy on Thursday, July 23, 2020.

According to the "Our Approach" section on Juniper's own website: "Juniper focuses on distressed or undervalued real estate assets that may require substantial repositioning and/or involve complex workout and restructuring issues."

In the "Investment Parameters" section they identify their investment size as "\$10M - \$250M".

Recent hospitality investments, both from 2019, include a lodge in New Mexico acquired using a \$15 million mezzanine loan and a 133-key hotel in New York acquired out of bankruptcy court for \$8 million.

At a major casino resort like Virgin Las Vegas, non-gaming operations play a significant role, it is of crucial important that non-gaming operations are run successfully. We encourage you to review Jay Wolf's background.

Good morning. Aira Mae Duyanen for the Culinary Union.

My comments concern the Rampart Casino at the Resort at Summerlin and the gaming license of Shirazalli Jafferali Lalji, who died March 28, 2020, but was listed as having an active gaming license until March 21, 2024.

Mr. Lalji was listed as an active beneficiary and director within the ownership structure of the Rampart Casino, according to a Nevada Gaming Control Board location details report for the property for March 15, 2024.

On March 21, we gave public comment to the Nevada Gaming Commission about Mr. Lalji, asking the Commission for clarification on whether Mr. Lalji should be removed.

That day the Nevada Gaming Control Board changed Mr. Lalji's status, as shown on the location details report, from "beneficiary and director" to "removed."

As of Monday April 17, the report lists Mr. Lalji as deceased within the casino's ownership structure, but continues to list him as "active."

Today we seek further clarification.

According to the Control Board report, Mr. Lalji died on March 28, 2020. His role as a "beneficiary" and "director" within the Rampart Casino ownership structure was marked "removed" on March 21, 2024.

We have two questions.

Why was a deceased Mr. Lalji listed as having a gaming license for almost four years after his death?

And why is a deceased Mr. Lalji still as of April 17, reported as active within the Rampart Casino ownership structure?

We request answers to these important questions. Thank you.
