2ND PUBLIC COMMENT - ATTACHMENT 1 AUGUST 22, 2024 Good morning. Aira Duyanen for the Culinary Union. I want to provide two updates about

Station Casinos and request the Board and Commission assign a staff person to monitor

ongoing legal proceedings and examine for exhibits potential violations of Nevada gaming law.

The first update is that in the United States Court of Appeals for the DC Circuit, the National

Labor Relations Board has moved for enforcement of its June 17 order against Red Rock Casino.

Red Rock Casino has asked for review. The case numbers are 24-1221, 24-1239, and 24-1240. If

the Court sides with the NLRB and workers, then the Board's order of June 17, 2024 requiring

Red Rock Casino to recognize and bargain with the union will be enforced. As a reminder, the

NLRB's June 17 order ruled that Red Rock Casino's "extensive coercive and unlawful

misconduct" between September 2019 and June 2020 "stemmed from a carefully crafted

corporate strategy" and that "the most important unfair labor practices were planned and

executed by Red Rock Casino and Station Casinos' top management and owners."

The second update is that down the street last week, one of the largest labor law enforcement

actions in history resumed. NLRB prosecutors and attorneys for Station Casinos made opening

arguments, and the General Manager for Red Rock Casino was called to the stand.

We will keep you updated on both of these legal proceedings. Our request today is that you

direct a staff person to monitor ongoing legal proceedings who can apprise you of issues that

may bear upon your duty to determine the ongoing suitability of officers and employees who

engaged in the administration or supervision of the activities of a corporate gaming licensee,

including the ability of such persons to testify truthfully under oath. The hearings here in Vegas

are open to the public.

2ND PUBLIC COMMENT - ATTACHMENT 2 AUGUST 22, 2024

LST.

We are here today to ask you for an answer to the following question: Is it acceptable to the Gaming Control Board and Commission that top executives of a Nevada gaming company should testify under oath in a federal proceeding "with such an unusual degree of evasiveness and wholly implausible forgetfulness" that a judge is "fully warranted in discounting their testimony as generally unreliable except where independently corroborated or against the Respondent's interest?" That is what the National Labor Relations Board found of Mr. Welch, Mr. Cootey, and others just this past June. As the guardians of the integrity of the Nevada Gaming Industry, what do you intend to do about it?

Good morning, my name is Rory Kuykendall and I'm with the Culinary Union. I'm here today to draw your attention to a major strike by employees of Evolution in the Central Asian country of Georgia.

Evolution announced last month that it was going to acquire Galaxy Gaming of Las Vegas, subject to regulatory approvals.¹

Evolution is a Swedish company that provides live casino games to various online casino operators in the U.S. and elsewhere. It is a fast growing and highly profitable company. In 2023, the company generated 1.8 billion Euros in operating revenues and 1.07 billion Euros in after-tax profit.² For the first half of 2024, it had just over 1 billion Euros of operating revenues and 538.3 million Euros in after-tax profit.³ Its EBITDA margin was 70.5% in 2023 and 68.5% in the first half of 2024.

According to company's latest annual report, "Tbilisi is [its] largest hub, where a mix of English-speaking and international game presenter teams are working." Evolution claims to have 8,000 workers in Georgia.

In spite of the company's financial success, these Evolution workers in Georgia are fighting for higher pay, better and cleaner working conditions, and basic respect on the job.

Civil Georgia, an NGO-run news site, reported in July 2023 that Evolution was advertising an entry-level game presenter job that paid from 900 Georgian lari to 1225 Georgian lari a month, about \$329 to \$450 a month. The National Statistics Office of Georgia reports that the average monthly nominal earnings in the first quarter of 2024 was about 1943.4 Georgian lari, or around \$718.5 a month.

On July 12 this year, more than 4,000 of these workers went on strike. The strike started after a legal process that included a 21-day mediation period that ended on June 25. The union gave the company notice three days prior to starting the strike. 9

On August 12, four of the workers started a hunger strike. 10

The Culinary Union offers our solidarity to the Evolution workers in Georgia. We ask the Nevada Gaming Commission to take into consideration the labor practices of this company, in Georgia and anywhere else, as you review their potential application for a Nevada gaming license related to the acquisition of Galaxy Gaming. We urge you to reject Evolution's application if it continues to refuse to treat its employees with respect and provide for decent wages and safe working conditions.
