Hello. My name is Diamante Asberry, and I am here on behalf of the Culinary Union.

Last November, Culinary Union members on the Strip won a record breaking contract that included historic wage increases and protections. Those Strip workers at casinos owned by MGM Resorts, Caesars Entertainment, and Wynn resorts fought and won a first-class standard for themselves and their families.

This month, nearly 8,000 hospitality workers at many Strip and Downtown Las Vegas properties also reached new tentative agreements for contracts that include historic wage increases and protections. These properties include Circus Circus, Hilton Grand Vacations, Rio, Sahara, the Strat, Treasure Island, Trump Hotel, Waldorf Astoria, Westgate, Binion's, Circa, Downtown Grand, El Cortez, Four Queens, Fremont, Golden Gate, Golden Nugget, Main Street, The D, and Plaza.

Securing these contracts took Culinary Union members over 2 years of preparation, 10 months of negotiations, lots of hard work, committee meetings, sleepless nights, and worker-led organizing. No victory in our union's history is ever guaranteed, and thousands of workers who participated in rallies, protests, civil disobedience, picketing, surveys, picket sign making, strike voting, and delegations inside the properties sacrificed to win a better future for themselves and their families. Just 2 weeks ago, Culinary Union members picketed for 12 hours straight for 2 days for themselves and in solidarity with their coworkers. One casino property reached a tentative agreement, and then workers would move to join a different picket line at a different property.

There is a reason workers at 7 Station Casino properties chose to be represented by the Culinary Union. Boulder Station in 2016. Then Palace Station. Then Green Valley Ranch. Then Sunset Station. Then Fiesta Rancho. Then Fiesta Henderson. Then Red Rock Resort. And then the pandemic came. Station Casinos put thousands of community members on MUD lists and used those lists to determine who got work. The NLRB alleges the company engaged in a scheme to use employee layoffs during the COVID-19 pandemic to undermine unions representing or seeking to represent their employees.

Station Casinos workers, like the hospitality workers on the Strip and in Downtown Las Vegas, will do whatever it takes to secure a fair union standard for themselves and their families.

My name is Mercedes Cabrera. I have worked at Green Valley Ranch for 17 years as a kitchen worker.

I am fighting for my benefits to be guaranteed by a contract and for my colleagues and I to have security in our jobs. We have been fighting for more than 10 years. 6 years ago we won our union election and Station Casinos said that it would respect the workers' decision and we still have not seen that respect.
