2024-04R: CONSIDERATION OF PROPOSED AMENDMENTS TO NGC REGULATION 10.041 TO REPEAL CERTAIN ENROLLMENTS WITHOUT AN APPLICATION TO THE NGC.

PURPOSE: To amend NGC Regulation 10 by repealing NGC Regulation 10.041; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated April 3, 2024, effective upon adoption.

2. FOR FINAL ADOPTION

2024-03R: CONSIDERATION OF PROPOSED AMENDMENTS TO NGC REGULATIONS 5.230, 5.2305, 5.231, 5.232, 5.240, 5.242, AND 5A.220 TO INCORPORATE HOSTING CENTER PROVISIONS AUTHORIZED BY THE NEVADA LEGISLATURE.

PURPOSE: To amend the Nevada Gaming Commission (“Commission” or “NGC”) Regulations to incorporate changes authorized in Sections 9.1 and 9.3 of Senate Bill 14 from the 82nd Session of the Nevada Legislature (2023); To amend NGC Regulation 5.231 to add new subsection defining what portions of the premises of a registered hosting center agents and members of the Nevada Gaming Control Board (“Board”) and Commission are to be granted access; To amend NGC Regulation 5.231 to add new subsection allowing a waiver of the requirements of new subsection 1; To amend NGC Regulation 5.231 to add a new subsection that states that it is an unsuitable method of operation for a registered hosting center to deny agents or members of the Board or Commission access to the premises or to inspect any aspect of its operation, or to fail to disclose any aspect of its operation to agents or members of the Board or Commission; To amend NGC Regulation 5.240(10) to add a new paragraph defining what portions of the premises of a service provider agents or members of the Board or Commission are to be granted access; To amend NGC Regulation 5.240(10) to add a new paragraph allowing a waiver of the requirements of the new paragraph (a); To amend NGC Regulation 5.240(10) to add a new paragraph stating that it is an unsuitable method of operation for a registered hosting center to deny agents or members of the Board or Commission access to the premises or to inspect any aspect of its operation, or to fail to disclose any aspect of its operation to agents or members of the Board or Commission; To amend NGC Regulation 5.240 by repealing subsection 16 as it is no longer necessary or relevant; To amend NGC Regulation 5.242 to add a new subsection permitting a waiver of the requirements of subsection 2 and to renumber the following subsections accordingly; To amend NGC Regulation 5.242 to add a provision to the attestation that the gaming licensee utilizing a cloud service provider must provide; To amend NGC Regulations 5.230(1) and (5), 5.232, and 5.242(9) to clarify that the requirements apply to entities and individuals; To make non-substantive amendments to various regulations to standardize and/or correct cross-references; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated March 7, 2024, effective upon adoption.

2024-03R: CONSIDERATION OF PROPOSED AMENDMENTS TO NGC REGULATION 6.110(2) TO AMEND THE GROSS REVENUE COMPUTATIONS FOR SLOT MACHINES' HOPPER LOADS.

PURPOSE: To amend the Nevada NGC Regulation 6.110(2) to remove the requirement that a licensee makes an annual adjustment to gross revenue for the difference between each slot machine’s hopper load at the beginning of the year and its hopper load at the end of the year; To add a requirement that if a slot machine that is equipped with a hopper is permanently removed from play or converted to a slot machine that is not equipped with a hopper, an adjustment must be made to drop for the difference between the initial hopper load and the funds in the hopper on the date the slot machine is removed or converted; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated March 7, 2024, effective upon adoption.

2024-03R: CONSIDERATION OF PROPOSED AMENDMENTS TO NGC REGULATION 8 TO CONSOLIDATE TRANSFERS OF INTEREST TO A SINGLE PROCESS.

PURPOSE: To condense transfers of interest to a single process; to repeal Regulation 8.020; to clarify that the transfer of interest process set out in regulation applies to all entities licensed, found suitable, or registered pursuant to the Gaming Control Act; to explicitly set out that the Commission approves all transfers of interest; to allow administrative approval of certain transfers of interest; to waive certain statutory and regulatory requirements to enable administrative approval of certain transfers of interest; to explicitly set out that the Commission may approve continuous transfers of interest; to recognize that certificates evidencing a transaction regarding the granting of a possessory security interest may no longer be physical, but be in digital form; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

Regulation adopted, draft dated April 3, 2024, effective upon adoption.

2024-03R: CONSIDERATION OF PROPOSED AMENDMENTS TO NGC REGULATION 2.040 TO MAKE CONFORMING CHANGES SHOULD NGC REGULATION 8.020 BE REPEALED.

PURPOSE: To amend Regulation 2.040 based on the repeal of Regulation 8.020; and to take such additional action as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated April 3, 2024, effective upon adoption.

Good morning. My name is Henry Joyner. I was born in Philadelphia. I moved to Las Vegas in 2005.

My first day of work at Red Rock Casino was in 2017 on the Fourth of July.

My last day of work at Red Rock Casino was this past Monday.

I never felt like I was treated equally or fairly when I worked at Red Rock.

In 2017 I was hired as a cook. But on my first day at the start of my shift I was handed a broom and made to do the job of a kitchen steward.

In 2019 I put on my Union button and I wore it every day with pride.

There is a reason workers at Red Rock chose to be represented by the Culinary Union.

In the kitchen I worked at in Red Rock there are 9 cooks on my shift.

The kitchen is divided into 5 work stations.

There should be about 2 cooks per station.

But I was made to work alone in my station without support.

Tickets come in, food goes down, food gets ready, food gets plated.

It's fast, hard work I had to do alone while other cooks on the line had support.

The stress of this work caused me to take pain medication.

At the start of every shift I took 3 extra strength Tylenol. Then mid shift a 500 IB-profen.

I did this for a long time and my doctor told me recently to stop.

I want a Union job where I am treated equally.

Any discrimination against any worker in the gaming industry needs to stop.

And again, I'm sad to say that I never felt like I was treated equally I worked at Red Rock.

Good morning. Rory Kuykendall for the Culinary Union.

Workers at Sunset Station Casinos voted by 83% to unionize on June 13, 2019. That was the only official vote the property ever had and it was overseen by the federal government. Workers voted in a landslide majority in favor of unionizing.

On April 19, Station Casinos withdrew recognition from the Culinary and Bartenders Union as the bargaining representatives at Sunset Station. Just as with Palace and Boulder, we believe it has done so unlawfully.

The same day as it withdrew recognition, Station Casinos announced that Sunset Station employees would now enjoy certain enhanced benefits that the company has offered only to non-union employees since January 2023.

The Culinary Union agreed, in December 2022, that Station Casinos should give the enhanced benefits to unionized workers at Sunset, Green Valley Ranch, and Red Rock Casino on equal terms as non-union employees. But the company still refuses to do the right thing and uses its weaponized benefit discrimination scheme in its union busting campaign.

We'd like to submit today for your review the April 19 memo from Jordan Seager, Sunset Station General Manager to unionized Sunset Station employees that we believe illustrates the benefit discrimination scheme.

An employer violates Section 8(a)(3) of the NLRA if it withholds benefits from union-represented employees that it grants to unrepresented employees if it does so for the purpose of discouraging support for the union.

Station Casinos, its parent company Red Rock Resorts Inc. and its properties face a series of National Labor Relations Board cases that together constitute one of the largest labor law enforcement actions in history.

A U.S. Administrative Law Judge ordered 4 days of hearings starting July 30th in an ongoing Unfair Labor Practice trial over a complaint issued in April 2021.

The evidence in the prosecution of Station properties is powerful and the prosecutors have messages and emails written by general managers and executives about the company's MUD List of employees and Boulder and Palace.

Mr. Frank and Lorenzo Fertitta must appear at the trial since Station Casinos lost its fight to block an order that they testify. They'll be testifying under penalty of perjury and we expect them to tell the truth.
