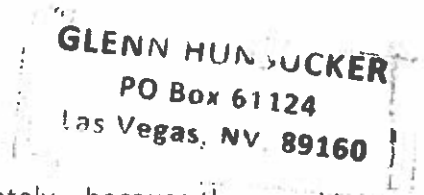

Roulette



Every roulette table in every casino-----should be closed down immediately---because they are fraudulent.-----here is the proof

- At the Orleans
 - One table had #27 show up 2 times in a row
 - The table next to it---also had the # 27 show up 2 times in a row
- At the gold coast
 - One table had the # 12 show up 2 times in a row
 - And 6 spins later---the # 5 showed up 2 times in a row.
- At the Aria---where Ayesha Molino works
 - The # double 0---showed up 2 times in a row
 - In the high roller lounge---the # 5---showed up 2 times in a row
 - 2 employees at the Aria said they see this often and in fact---they see a number show up 3 and 4 times in a row.
- I can give you 100 examples from 100 casinos where this happens every day at every roulette table.
- In fact---you can go see for yourself at any casino at any time.
- The point is---this is proof that casinos can control the outcome of the game---and allow anyone to win---by allowing their number to come up.
- As long as this continues---there will always be a suspicion surrounding the members of this board and your motivation for-----**NOT DOING ANYTHING ABOUT**
- Before issuing Ayesha Molino a gaming license----I would want her to answer some questions under oath--such as:
 - In the years she has walked by roulette tables-----has she seen a number come up 2 or 3 times at a row?—
 - Has she had conversations with other executives or casino owners----about the casino games being fraudulent.
 - It **doesn't matter exactly** how casinos cause one number to come up 2 or 3 times in a row.
 - what matters is----it happens----and it happens every day ----in every casino---all over the world.
 - Therefore---all roulette tables should be closed as soon as possible.

Quick lesson on Odds/statistics on roulette

Note: each Roulette wheel is not played that often. They are closed most of the time, except some nights and week ends.

- This means that to have 1,369 spins, would require a month or more of spins.
- To have 1,874,161 spins, would take over 20 years.

Good morning. Zachary Poppel for the Culinary Union.

My comments this morning are about owners of the largest gaming company in the second largest gaming market in the U.S. being called to the witness stand and put under oath.

Counsel for the National Labor Relations Board may call to the witness stand the controlling owners of Station Casinos, Mr. Frank Fertitta III and Mr. Lorenzo Fertitta. They must appear at this ongoing NLRB trial before Administrative Law Judge Amita Tracy since Station Casinos lost its fight to block an order that they testify.

Counsel for Station Casinos challenged the subpoenas and argued that the Fertitta brothers should not be compelled to testify, arguing in a October 2021 motion that "Any question designed to embarrass, badger, demean, or to sensationalize the Fertittas' personal beliefs, personal lives, wealth, outside business interests, or other such topics have no possible relevance, materiality or other bearing on any issues before Judge Tracy."

In Judge Tracy's denial of Station Casino's counsel motion to block or revoke the subpoenas to testify, she wrote in August 2021 that "It is reasonable to conclude that the Fertitta brothers may have relevant information that may advance the General Counsel's case or rebut any anticipated defenses." And that, "As will all witnesses, and the Fertitta brothers' testimony shall be no different, such testimony will not be a 'fishing expedition.'"

With respect to Mr. Frank Fertitta, Judge Tracy said in August 2021 that he may have knowledge about messages in 2020 to employees that allegedly misled employees and disparaged Unions. And NLRB General Counsel exhibits include a text message from the then-Station Casinos Chief Operating Officer to Mr. Lorenzo Fertitta about a campaign at Boulder Station that the government alleges was an unlawful management-run effort to decertify the union.

In October 2021, counsel for Station Casinos sought to limit each Fertitta brother's time on the witness stand to no more than two hours. Judge Tracy has yet to rule on this, but we are confident that more than 4 hours of combined testimony will be required.

Since the effort to block their testimony failed, we believe that each Fertitta brother should do what any of us should do if we were called to the witness stand—give truthful testimony, answer all the questions the judge allows and not be concerned with how many hours it takes.

And we again urge the Board and Commission to assign a staff person to monitor these hearings in person, particularly when a gaming license holder is on the stand. Thanks.

I have worked in Las Vegas for 27 years. I have worked at Sunset Station for 14 years.

In 2019 on June 13 there was a union election at Sunset Station.

If you won an election by 83% would you ever give up?

If your coworkers won the right to bargain for a better life would they ever give up?

I will never give up.

We go one day at a time and know that we will win a union contract at Sunset Station.


