Good morning. My name is Adam Christian.

I work at Red Rock Casino at T-Bones.

I've worked there for 18 years.

There is a certain type of power in a Union button. My employer is anti-union, so my union button takes on a special type of power.

On December 10, 2019, the Chief Legal Officer of Station Casinos sent a text message to Frank and Lorenzo Fertitta and Chief Financial Officer Stephen Cootey.

Good morning. Zachary Poppel for the Culinary Union.

On July 29 counsel for Station Casinos filed a statement of issues to be raised in the U.S Court of Appeals DC Circuit. The filing shows Stations Casinos' company is rolling the dice in federal court to see if they can fundamentally restructure labor law enforcement in our country by challenging the constitutionality of the National Labor Relations Board. According to Station Casinos, the system of federal law enforcement and its judges that hold Station Casinos accountable somehow violates their rights under the Constitution. This claim about the Constitution comes from a Nevada gaming company that violates federal labor law over and over again. In fact, the size and weight of Station Casinos violations have slowed down the NLRB and prevented a final legal reckoning in one of the largest labor law enforcement actions in US history.

We have a copy of their July 29 filing to turn in along with these comments.

We are concerned about what Station Casinos' challenge to the constitutionality of labor law enforcement means for Nevadans and the gaming industry. Nevada gaming industry workers have federal rights they depend on to win respect at work and to win better pay and benefits for their families. There is a law enforcement system that preserves the fundamental freedom to join a union. And now you have a large gaming employer arguing in federal court that that law enforcement system that preserves the fundamental freedom to join a union should not exist as it does at present.

Essential to that federal labor law enforcement system is telling the truth and nothing but the truth in law enforcement proceedings. And we again must restate the fact that the top of the NLRB found that top executives Station Casinos testified under oath in a federal proceeding "with such an unusual degree of evasiveness and wholly implausible forgetfulness" that a judge was "fully warranted in discounting their testimony as generally unreliable except where independently corroborated or against the Respondent's interest." At question was whether the Chief Operating Officer, the Chief Legal Officer, the Chief Financial Officer, the top labor strategy or HR executive, could provide credible testimony about

significant matters related to labor strategy and how they discussed that strategy with the owners of the company. In law enforcement proceedings gaming company executives need to give credible, truthful testimony about significant company strategies and need to give credible, truthful testimony about how owners engage in those strategies. No gaming company or its executives should have problem with the truth and telling it.

Tomorrow is another hearing in the ongoing labor law trial against Station Casinos. We again urge the Board to assign a staff person to monitor the proceedings in person, particularly when a gaming license holder is on the stand. Thanks.
