Good morning. Aira Duyanen for the Culinary Union. The U.S. agency in charge of federal labor law enforcement obtained texts and emails between Station Casinos executives and directors in response to a subpoena in one of the largest labor law enforcement actions in U.S. history. An example are certain emails between Station Casinos's former Chief Operating Officer and the former General Manager of Green Valley Ranch about creating a MUD List for GVR.

We know that Station Casinos executives ordered supervisors to create M.U.D. Lists during the pandemic to keep track of which employees were pro-management (M), pro-union (U), or don't know (D). Among other nefarious purposes, there is evidence that Stations used these designations to "vet" certain employees who had lost their jobs as a result of the pandemic to determine whether they should be rehired. It is illegal for an employer to discriminate based on union preference when hiring workers.

But M.U.D. lists were used for other reasons as well. On July 3, 2020 at 11:19 am, the COO sent an email to the GM at GVR stating, "I shared your thoughts following in the footsteps of Palace and Boulder. Has your Team prepared a MUD List for GVR? If you have and would like [Senior Vice President of Corporate HR] and me to come over next week to meet with you and your Team to discuss next steps let me know and we can get something scheduled. "A few minutes later, the GM wrote back, "Yes that would be great. We have not prepared a MUD list yet. With the busy holiday weekend, we will get one completed by Wednesday next week." A minute later, the COO answered, "Sounds good. Do you want me to schedule something for late next week or wait until you confirm you have the list?"

At the very time that GVR's General Manager was expressing his desire to follow in the "footsteps of Palace and Boulder," Station Casinos was orchestrating a campaign at those properties to solicit employees to sign anti-union petitions. It would later use these petitions to withdraw recognition from the union. The federal government alleges in the ongoing ULP trial that Station's actions was illegal. The MUD lists were entered as a key piece of evidence at the trial.

You should ask yourselves: During the middle of a pandemic when Nevada workers were literally dying, why would the Chief Operating Officer of a company that your agency regulates think it was necessary to solicit a list of gaming employees' sentiments about unions? Why would that COO push for a meeting about the next steps pertaining to that MUD List? You have the authority to investigate whether this company is adhering to the high standards necessary to operating a gaming enterprise in our state. You should do so. Thank you.

Hello, my name is Matthew Lopez. I'm 29 years-old, and I work as a bellman at Station Casinos' Green Valley Ranch.

I was raised over the hill in Boulder City and started working at Green Valley Ranch in 2016 at 21-years-old.

As a bellman, not only do we deliver carts full of luggage and coolers through long hallways, we also drive high rollers all over the Las Vegas Valley - to and from the airports, casinos, and almost anywhere they want.

I make just a little over minimum wage. Minimum wage is twelve dollars per hour and my hourly wage is a dollar eighty six over that.

In the last nine years, my co-workers and I voted to go union with a 78% vote YES. However, in these last few years our feeling of being disrespected has only grown.

The raises are insufficient and rare, our hours are inconsistent, and the appreciation days are basically glorified pizza parties.

I believe that one job should enough so myself and my coworkers earn fair wages with predictable guaranteed wage increases and job security with consistent scheduling.

This isn't just about our present, but our future too.

When someone enjoys what they do it's easy to ignore the bad.

In situations like these, I hope the company sees that I am more than just a number.
