**Chairman Hendrick thanked Boulder City for letting us use their space. Member Assad recognized the recent passing of a North Las Vegas police officer. Member Sendall echoed Member Assad's comments honoring Officer Roscow, and also thanked everyone for welcoming her to the Board.**

Good morning. Diamante Asberry for the Culinary Union. Essential to a law enforcement system is telling the truth and nothing but the truth in law enforcement proceedings. As we have told you before, the National Labor Relations Board found that top executives Station Casinos testified under oath in a 2021 federal proceeding “with such an unusual degree of evasiveness and wholly implausible forgetfulness” that a judge was “fully warranted in discounting their testimony as generally unreliable except where independently corroborated or against the Respondent’s interest.”

At question was whether the Chief Operating Officer, the Chief Legal Officer, the Chief Financial Officer, and its Vice President of HR charged with overseeing labor strategy provided credible testimony about that labor strategy and how they discussed it with owners of the company. In law enforcement proceedings, gaming company executives need to give credible, truthful testimony about significant company strategies and how owners engage in those strategies. No gaming company or its executives should have a problem testifying truthfully and without evasiveness in any kind of law enforcement proceeding.

In the 2021 hearing, a lawyer for the federal agency tasked with labor law enforcement questioned the HR executive in charge of labor strategy about MUD lists, which are lists that Station created indicating which employees were pro-management, which were pro-union, and which were “don’t know.” The lawyer for the government asked the executive: “So would there be departmental MUD lists?” The executive responded, “Sure.” The government lawyer then asked, “Have you ever seen one of them?” The Station executive asked: “Have I physically seen a MUD list?” The government lawyer responded: “Yeah, let's say for Red Rock.” “No, I've never seen one,” the Station executive responded.

We find this testimony to be highly implausible. This same Station executive was responsible for introducing the concept of MUD lists to the company, for providing training to managers about creating MUD lists, and for reviewing MUD lists with subordinates as part of Station’s scheme to get rid of the Union. We think it defies belief that he never saw one of the lists that he instructed those under him to create.

We encourage the Board to ensure all license holders give credible testimony when under oath. If they can’t do that, they don’t deserve to operate gaming enterprises in our State.
