(1) THE WAIVER OF THE PROVISIONS OF NGC REGULATION 4.080, IN CONJUNCTION WITH THE APPROVAL GRANTED IN AUGUST 2024, SHALL EXPIRE ON THE DATE OF THE REGULARLY SCHEDULED NGC MEETING IN AUGUST 2025.
