Good morning. Diamante Asberry for the Culinary Union. The state of Nevada depends on gaming industry workers organizing for higher standards for themselves, their families and our community.

We want to talk about what Red Rock Casino employees have endured. It is worth restating part of the decision reached in 2024 by the top labor law enforcement body in the United States.

“The centerpiece of the [Red Rock Casino’s] unlawful campaign was its tripart message promising and granting employees tremendous new benefits without the Union, threatening to withhold or withdraw these benefits if employees selected the Union, and implicitly threatening that selecting the Union could only lead to years of fruitless bargaining without any improvement to working conditions. This highly coercive combination of promises and threats was accompanied by a barrage of further unlawful conduct, including additional threats that selecting the Union would lead to withdrawal of “favors,” “extras,” or “help” that employees could otherwise expect from management, implicit threats of job loss related to strikes, and interrogation and discriminatory treatment of Union supporters. The coercive impact of these unfair labor practices was magnified because they were committed by the Respondent’s highest-ranking executives, including Red Rock General Manager and Station Casinos Senior Vice President for Human Resources, as well as other managers and supervisors at all levels.” The top labor law enforcement body in the United States also decided that at Red Rock Casino “the most important unfair labor practices here were planned and executed by the Respondent’s and Station Casinos’ top management and owners, for the express purpose of interfering with employees’ [organizing rights].”

Red Rock Casino still continues to litigate this decision before the DC Circuit Court. We are confident that the facts and the truth are on the side of the workers. No gaming license holder should threaten, intimidate, interrogate or discriminate against gaming workers who power the industry. Thanks.

My name is Casiano Corpus. I have worked at Palace Station as a Utility Porter for 32 years.

I am a union committee leader inside Palace Station, which means I talk to my coworkers and organize them to fight for a union contract. The reason I became a union committee leader was so that I could provide a better life and future for my family. I want to have better pay, a pension, and better insurance.

Station Casinos does not want to give us what we are asking for. Every day I go to work, I am afraid because I don't know which day might be my last day.

We only want Station Casinos to respect the daily struggle of us employees, and to sit with us at the negotiating table and sign a union contract.
