#### PURPOSE:

In accordance with NRS 463.145 and 463.150, to amend Regulation 5.045 to require that any compliance review and reporting system required by the Commission must designate a compliance committee responsible for overseeing the system; the written plan must provide for the involvement on the compliance committee of at least one independent member who possesses extensive knowledge of the Nevada Gaming Control Act and the regulations of the Commission; provide for the meaning of "independent member;" and to take such additional action as may be necessary and proper to effectuate these stated purposes.
