<u>GCB RECOMMENDS:</u> APPROVAL, CONDITIONED:

1) THE APPROVALS REGARDING MICHAEL GAUSELMANN ARE LIMITED TO EXPIRE AT MIDNIGHT OF THE MAY 2027 NEVADA GAMING COMMISSION MEETING ON THE DAY THE ITEM IS HEARD.

THE FOLLOWING CONDITION PERTAINS TO GAUSELMANN FAMILIENSTIFTUNG:

1) GAUSELMANN FAMILIENSTIFTUNG SHALL NOT MAKE ANY DISTRIBUTIONS OF GAMING REVENUE DERIVED FROM NEVADA LICENSED OPERATIONS TO ANY UNLICENSED BENEFICIARIES UNTIL THE BENEFICIARY HAS BEEN FOUND SUITABLE AS A BENEFICIARY OF GAUSELMANN FAMILIENSTIFTUNG BY THE NEVADA GAMING COMMISSION.

THE FOLLOWING CONDITIONS PERTAIN TO MERKUR.COM AG:

- 1) MERKUR.COM AG, SHALL, WITHIN 90 DAYS FOLLOWING THE DATE OF THE MAY 2025 COMMISSION MEETING, ESTABLISH AND MAINTAIN A GAMING COMPLIANCE PLAN (PLAN) FOR THE PURPOSE OF, AT A MINIMUM, PERFORMING DUE DILIGENCE, DETERMINING THE SUITABILITY OF RELATIONSHIPS WITH OTHER ENTITIES AND INDIVIDUALS, AND TO REVIEW AND ENSURE COMPLIANCE BY MERKUR.COM AG, AND ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES, WITH THE NEVADA GAMING CONTROL ACT (THE ACT), AS AMENDED, THE COMMISSION'S REGULATIONS (THE REGULATIONS), AS AMENDED, AND THE LAWS AND REGULATIONS OF ANY OTHER JURISDICTION IN WHICH MERKUR.COM AG, ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES OPERATE. THE PLAN, ANY AMENDMENTS THERETO, AND THE MEMBERS OF THE GAMING COMPLIANCE COMMITTEE, ONE SUCH MEMBER WHO SHALL BE INDEPENDENT AND KNOWLEDGEABLE OF THE ACT AND REGULATIONS, SHALL BE ADMINISTRATIVELY REVIEWED AND APPROVED BY THE NEVADA GAMING CONTROL BOARD CHAIR OR THE CHAIR'S DESIGNEE. MERKUR.COM AG, SHALL AMEND THE PLAN, OR ANY ELEMENT THEREOF, AND PERFORM SUCH DUTIES AS MAY BE REQUESTED OR ASSIGNED BY THE NEVADA GAMING CONTROL BOARD CHAIR OR THE CHAIR'S DESIGNEE RELATING TO A REVIEW OF ACTIVITIES RELEVANT TO THE CONTINUING QUALIFICATIONS OF MERKUR.COM AG, UNDER THE PROVISIONS OF THE ACT AND REGULATIONS.
- 2) MERKUR.COM AG, SHALL FUND AND MAINTAIN WITH THE NEVADA GAMING CONTROL BOARD, A REVOLVING FUND IN THE AMOUNT OF \$50,000 FOR THE PURPOSE OF FUNDING INVESTIGATIVE REVIEWS BY THE NEVADA GAMING CONTROL BOARD. WITHOUT LIMITING THE FOREGOING, THE NEVADA GAMING CONTROL BOARD SHALL HAVE THE RIGHT, WITHOUT NOTICE, TO DRAW UPON THE FUNDS OF SAID ACCOUNT FOR THE PAYMENT OF COSTS AND EXPENSES INCURRED BY THE NEVADA GAMING CONTROL BOARD AND ITS STAFF IN THE SURVEILLANCE, MONITORING AND INVESTIGATIVE REVIEW OF ALL ACTIVITIES OF MERKUR.COM AG, AND ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES.

THE FOLLOWING CONDITION PERTAINS TO MERKUR GAMING US, LLC:

PUBLIC COMMENTS AND DISCUSSION: No comments.

Good morning. Aira Duyanen for the Culinary Union. My comments are about Station Casinos Chief Financial Officer Stephen Cootey. Mr. Cootey's job duties include "devot[ing] full time and attention to the business and affairs of the Company," according to his employer's 2017 filing with the SEC. A CFO of a publicly traded, Nevada gaming company should be credible when testifying under oath about significant matters. We know that in September 2022 the Commission discussed in a licensing hearing Mr. Cootey's ability to recall a significant event involving law enforcement.

In November 2019, Mr. Cootey was in the meeting with Station Casinos owners and others executives where senior management made a written presentation seeking approval for millions of dollars in spending to finance new health and retirement benefits. The presentation emphasized key points through underlined and red-bolded text to stress how funding the benefits would take away union power and disincentivize employees from supporting it. In December 2019, Mr. Cootey was a participant in a group text chat with Station Casinos owners where its Chief Legal Officer crowed that employees had removed union buttons after meetings announcing the benefits. So Mr. Cootey was in a meeting with underlined, bolded red content and in a group chat with updates about the roll out of plans partly discussed in that meeting.

Yet, according to the judge that presided over the unfair labor practice trial, Mr. Cootey and other executives testifying under oath "refused to admit that that there was any discussion at the meeting regarding the underlined and bolded red points in the health insurance and retirement proposals about incentivizing employees not to vote for a union and taking away union power." The judge found Mr. Cootey's account not to be credible. Station Casinos is appealing that finding, but you should ask yourselves why there should even be a doubt about Mr. Cootey's ability to provide transparent testimony in a government proceeding. As the Chief Financial Officer, Mr. Cootey is supposed to devote his full time and attention to the business and affairs of the Company. COMMENTS OF ASSOCIATION OF GAMING EQUIPMENT MANUFACTURES ON PROPOSED REVISIONS TO NGC REGULATION 5.045

May 7, 2025

Good afternoon, Chair Hendrick, Members Assad and Sendall and Executive Secretary Rupert. I am Dan Reaser of Fennemore, appearing on behalf of AGEM, the Association of Gaming Equipment Manufacturers.

AGEM embraces the opportunity to participate in a reexamination of Regulation 5.045 which underwent a major revision just a little over five years ago. In pursuing this effort, AGEM recommends that the Board and Commission cast a wide net in soliciting input on the experience of all segments of the gaming industry in performing the Compliance Internal Reporting Systems ("**CIRS**"), and the effective oversight of the CIRS through the corporate governance structure selected by regulated companies.

As we embark on this effort, AGEM would make a handful of observation about topics for dialog:

- We should resist the inclination to create a single one size fits all approach to this regulatory compliance effort and be respectful of the business judgment by corporate boards of directors in selecting as fiduciaries the governance structure that best serves all the stakeholders of registrants and licensees.
- Likewise, we need to be open to the proposition that given the dynamic nature of the regulatory compliance environment, the rules should not inhibit innovation in how to organize this corporate function. The gaming industry enjoys neither exclusivity of thought leadership in this space nor a monopoly on creative implementation solutions.
- As it exists today, Subsection 5 of the Regulation has been carefully crafted to provide flexibility fostering different approaches to the CIRS oversight function. It allows for the compliance apparatus to be a committee of the board of directors, to be a department of an enterprise, to function as a wholly independent body and a variety of structures mixing and matching these approaches. The proposal appears to envision only a dedicated committee method and insists that only an independent member of the committee may

qualify as the repository of Nevada regulatory knowledge. Today, those requirements can be satisfied in a variety of ways that will be eliminated n the proposal.

- We need to explore how the Board and Commission envision the proposed "extensive knowledge" test to be satisfied. As drafted, this standard is too subjective.
- There is good cause to also evaluate the "independence" test articulated in the proposed rule. As the proposal is drafted, it appears far more restrictive and in potential conflict with the standards applied by the stock exchange listing requirements, Securities and Exchange Commission (SEC) regulations, proxy advisories and the incorporation laws of many jurisdictions. In this regard, care must be exercised to draft a rule that recognizes that many gaming companies are global firms. Regulation 5.045 should reflect the public policy balance envisioned by the Corporate Gaming Act of 1969, which is promote the benefits of broaden the opportunity for investment in Nevada gaming through the pooling of capital and promoting a competitive industry.

AGEM reiterates the commitment to support a robust dialog on revisiting proposed revisions to Regulation 5.045. We welcome the opportunity to respond to any questions.
