2019-04R: CONSIDERATION AND RECOMMENDATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 3 REGARDING, WITHOUT LIMITATION, EMPLOYEE REPORTS.

PURPOSE: In accordance with NRS 463.145, NRS 463.150, and S.B. 46 passed during the 2019 Legislative Session, to amend Regulation 3.100 to remove service provider and replace with interactive gaming service provider as falling within the definition of "qualifying employee" and subject to the employee reporting requirements; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
