- (1) CG TECHNOLOGY HOLDINGS, L.P., SHALL MAINTAIN THE EXISTING GAMING COMPLIANCE PROGRAM FOR THE PURPOSE OF, AT A MINIMUM, PERFORMING DUE DILIGENCE, DETERMINING THE SUITABILITY OF RELATIONSHIPS WITH OTHER ENTITIES AND INDIVIDUALS, AND TO REVIEW AND ENSURE COMPLIANCE BY CG TECHNOLOGY HOLDINGS, L.P., AND ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES, WITH THE NEVADA GAMING CONTROL ACT (“THE ACT”), AS AMENDED, THE COMMISSION’S REGULATIONS (“THE REGULATIONS”), AS AMENDED, AND THE LAWS AND REGULATIONS OF ANY OTHER JURISDICTION IN WHICH CG TECHNOLOGY HOLDINGS, L.P., ITS SUBSIDIARIES, AND ANY AFFILIATED ENTITIES OPERATE. THE GAMING COMPLIANCE PROGRAM, AND ANY AMENDMENTS THERETO, SHALL BE ADMINISTRATIVELY REVIEWED AND APPROVED BY THE CHAIR OF THE BOARD OR THE CHAIR’S DESIGNEE, AND THE MEMBERS OF THE COMPLIANCE COMMITTEE, ONE SUCH MEMBER WHO SHALL BE INDEPENDENT AND KNOWLEDGEABLE OF THE GAMING ACT AND REGULATIONS, SHALL BE ADMINISTRATIVELY ACKNOWLEDGED BY THE CHAIR OF THE BOARD OR THE CHAIR’S DESIGNEE. CG TECHNOLOGY HOLDINGS, L.P., SHALL AMEND THE GAMING COMPLIANCE PROGRAM, OR ANY ELEMENT THEREOF, AND PERFORM SUCH DUTIES AS MAY BE ASSIGNED BY THE CHAIR OF THE BOARD OR THE CHAIR’S DESIGNEE, RELATED TO A REVIEW OF ACTIVITIES RELEVANT TO THE CONTINUING QUALIFICATION OF CG TECHNOLOGY HOLDINGS, L.P., UNDER THE PROVISIONS OF THE ACT AND REGULATIONS.**
- (2) CG TECHNOLOGY HOLDINGS, L.P., SHALL FUND AND MAINTAIN WITH THE BOARD A REVOLVING FUND IN THE AMOUNT OF \$25,000 FOR THE PURPOSE OF FUNDING INVESTIGATIVE REVIEWS BY THE BOARD.
