1. FOR FINAL ADOPTION

2019-05R: CONSIDERATION AND RECOMMENDATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5 REGARDING, WITHOUT LIMITATION: REQUIREMENTS ADDRESSING WORKPLACE DISCRIMINATION AND HARASSMENT PREVENTION AND RESPONSE; REQUIREMENTS ADDRESSING OTHER GAMING BUSINESSES; AND OTHER NON-SUBSTANTIVE MODIFICATIONS.

PURPOSE: To amend the Nevada Gaming Commission ("NGC") Regulations to set forth the requirement that certain Nevada gaming licensees adopt and implement written policies and procedures prohibiting workplace discrimination and harassment; to amend regulation 5.011 to clarify that the provisions apply to a registrant and person found suitable by the NGC; to amend regulation 5.011(8) to clarify that the provisions set forth therein apply to all gaming businesses, not just licensed gaming establishments; to make various non-substantive stylistic changes to the regulation to conform with standard rulemaking guidelines; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated November 6, 2019, with changes as discussed. Section 5.011 effective upon adoption and remaining sections effective March 1, 2020.

2. FOR FINAL ADOPTION

2019-03: CONSIDERATION AND RECOMMENDATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 6 REGARDING, WITHOUT LIMITATION, CALCULATION OF GROSS REVENUE.

PURPOSE: In accordance with NRS 463.145, NRS 463.150, NRS 463.1595, and S.B. 46 passed during the 2019 Legislative Session, to amend Regulation 6.110(12)(a) and (c) to make the taking of certain deductions discretionary as opposed to mandatory; to create a new subsection (13) to Regulation 6.110 to provide for the calculation of gross revenue for contests and tournaments conducted in conjunction with a game or gaming device; to reformat certain non-substantive provisions in Regulations 6.110(12) and 6.120(3); and to take such additional action as may be necessary and proper to effectuate these stated purposes.

Regulation adopted, draft dated November 7, 2019, effective upon adoption.

3. FOR FINAL ADOPTION

2019-06R: CONSIDERATION AND RECOMMENDATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 16 REGARDING, WITHOUT LIMITATION, REQUIREMENTS AND PROCEDURES RELATING TO THE FILING OF AN APPLICATION FOR A FINDING OF SUITABILITY BY A PERSON ENGAGING IN CERTAIN PROSCRIBED ACTIVITIES.

PURPOSE: To amend Nevada Gaming Commission ("NGC" or "Commission") Regulation 16 to adopt the regulations mandated by Section 10.6 of Senate Bill No. 73 from the 80th (2019) session of the Nevada Legislature; to adopt regulations setting forth procedures by which a person, before engaging in certain proscribed activities, directly or indirectly, to materially influence or affect the affairs of a publicly traded corporation that is registered with the Commission, must file an application for a finding of suitability pursuant to Nevada Revised Statute (NRS) 463.643; to adopt regulations setting forth provisions that determine which corporate activities, in addition to those described in subsection 6 of NRS 463.643, influence or affect the affairs of a corporation in such a way that the Commission would require a person to file an application for a finding of suitability pursuant to NRS 463.643; to adopt regulations that provide provisions that ensure that a person is not unduly prohibited from lawfully exercising any of his or her voting rights derived from being a shareholder of a publicly traded corporation; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated November 6, 2019, effective January 1, 2020.
