2019-01RP: CONSIDERATION OF ADOPTION OF AMENDMENTS TO TECHNICAL STANDARD 3.150 OF NEVADA GAMING COMMISSION REGULATION 14 REGARDING, WITHOUT LIMITATION, LIMITS ON ELECTRONIC FUNDS TRANSFERS USING A DEBIT INSTRUMENT IN A CASHLESS WAGERING SYSTEM.

**PURPOSE:** To consider amendments to Tech Standard 3.150 of Nevada Gaming Commission ("NGC" or "Commission") Regulation 14 proposed in the Petition to Amend Technical Standard 3.150 submitted by Automated Cashless Systems, Inc. on or about September 4, 2019, and the subsequent amendment to the Petition submitted on December 16, 2019, which include, pursuant to the authority set forth in Subsection 7 of NGC Regulation 14.050, removing the existing daily limit for electronic funds transfers using a debit instrument in a cashless wagering system, or in the alternative, increasing the per transaction transfer limit, not to exceed \$10,000, for electronic funds transfers using a debit instrument in a cashless wagering system that is not to exceed a per day cumulative amount as determined by the establishment, or in the alternative providing an electronic funds transfer limit using a debit instrument in a cashless wagering system that is not to exceed a per day cumulative amount as determined by the establishment, or in the alternative providing an electronic funds transfer limit using a debit instrument in a cashless wagering system that is not to exceed \$10,000 per transaction and a per day cumulative amount as determined by the establishment; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Adopted, draft dated January 16, 2020, with additional amendment dated February 17, 2020 as discussed. Effective upon adoption, except as stated therein.
