PURPOSE: In accordance with NRS 463.145, NRS 463.150, and Assembly Bill 8 of the 81st Session of the Nevada Legislature, to provide definitions of "credit instrument" and "electronic signature;" to change the number of audited financial statements that must be submitted to the Board; to clarify who can attest that a system of internal controls satisfies requirements; to change the number of reports an independent accountant must prepare and provide to the licensee; to change the number of internal auditor's reports that must be submitted to the Board and clarifying when such reports must be submitted; to change the number of reports an independent accountant engaged by an operator must submit to the operator; to amend provisions related to the calculation of gross revenue including provisions related to payout receipts and wagering vouchers and provisions related to contests or tournaments; to amend provisions related to credit applications and credit instruments including clarifying that a licensee to comply with applicable provisions of NRS chapter 719 if it accepts an electronic signature on a credit instrument; to amend provisions related to the treatment of credit instruments upon conclusion of gaming operation; to amend provisions related to the mandatory count procedure including allowing for electronic submissions; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
