This public comment agenda item is provided in accordance with NRS 241.020(2)(c)(3) which requires an agenda provide for a period devoted to comments by the general public, if any, and discussion of those comments. No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action will be taken. Comments by the public may be limited to three minutes as a reasonable time, place and matter restriction, but may not be limited based upon viewpoint.

PUBLIC COMMENTS AND DISCUSSION: No comments.

My name is Casiano Corpus. I have worked at Palace Station as a Utility Porter for 30 years. I am here to speak to you again.

I am a union committee leader inside Palace Station. I talk to my coworkers and organize them to fight for a union contract. I am doing this for the good of my family, for my wife and two boys.

I want to have better pay, a pension, and better health insurance.

I want a union contract that guarantees those things.

We want Station Casinos to respect us and sign a union contract.

We are not going to stop fighting until we win.

Please help us.

Thank you very much, and God bless.

My name is Ken Liu. I'm with the Culinary Union. First of all, it's election season. Please make sure you vote. Every vote counts.

And today I want to bring your attention to potential violations of federal election law by Frank Fertitta III and Lorenzo Fertitta, who are controlling owners of Station Casinos and holders of suitability findings.

The Fertittas made \$756,300 in political contributions at the federal level between 2019 and 2021. The Federal Election Commission reports by the recipients of these donations contain false, outdated information.

For example, in December 2019, Lorenzo Fertitta made a contribution of \$147,000 to the McConnell Victory Committee. The receipt lists his employer as UFC and occupation as CEO. The Fertittas sold the UFC in 2016 and sold their remaining minority stake in 2017, so the information on Mr. Fertitta's donation receipt is years out of date and as a result false. There are 24 other similar reports of false, outdated information about employer and occupation on the receipts of Fertittas' donations between 2019 and 2021.

The Culinary Union submitted a letter to the FEC in April to ask for a determination as to whether this inaccurate information was knowingly submitted in violation of Title 52 of the US Code on voting and elections. The FEC has numbered this as a matter under review. As of today, we have not been notified of any final action.

While federal regulators review this matter, we urge you to directly ask Station Casinos about such false, outdated information related to political contributions by its controlling owners. We think it is important to find out whether Frank Fertitta and Lorenzo Fertitta might have been responsible for inaccurate information being reported to the FEC.

Specifically, we ask you to consider whether Frank and Lorenzo Fertitta might have failed to "comply with or make provision for compliance with all federal, state, or local laws and regulations" under Nevada Gaming Regulation 5.1
