PUBLIC COMMENTS AND DISCUSSION: No comment.

Good morning. Diamante Asberry for the Culinary Union. In our November public comment we told you about how *Time Magazine* included a mention of Station Casinos' MUD Lists of its own workers. MUD is an acronym and these are spreadsheets used to categorize employees as "pro-Management," "pro-Union," or "Don't know." Then in public comment we showed how Station Casinos property directors used MUD lists to decide which workers to rehire during the pandemic. Our last public comment showed how Station Casino Chief Operating Officer requested MUD Lists. Executives ordered supervisors to create MUD Lists.

These MUD Lists caused damage to our community and to our industry. No one in this room, no one in our community deserves to be put on a MUD List. Some of us may know the phrase "your name is mud." Station Casinos put the names of our own community members on its MUD Lists. How shameful. So today we want you to hear from workers who were on a Station Casinos MUD List.

But before you hear from them, let me say two things about Station Casinos and Red Rock Resorts Inc's internal governance. The company's board of directors Nominating and Corporate Governance committee is tasked with overseeing an annual evaluation of the Board and management, and the recommendation of improvements when necessary. We want to know whether the company's use of MUD Lists have been part of an annual evaluation by the Board, and if so, what the recommendations were. If the Governance committee has not evaluated how the company's MUD Lists effect employees like Kathleen and Adam, then is it following its charter?

And lastly, Red Rock Resorts' Code of Business Conduct and Ethics says that "All Team Members, suppliers, representatives and agents of the Company must conform to ethical and legal standards, abide by the law, and preserve the Company's integrity and reputation." Does the MUD List violate the company's own code? There is nothing ethical about a MUD List. A MUD List shows no integrity. A MUD List says more about the company who made the list than it does about the workers on the list. Thanks.

Hello. My name is Kathleen Penna. I have been a cocktail server for Station Casinos for nearly 26 years, 18 of them at Red Rock.

I am a union committee leader, and I wear my union button to work every day. I am on the company's MUD list as "union."

Why would the company do that to me? My most recent evaluation was outstanding across the board, with no infractions or points, and perfect attendance. In the comments managers said I am an asset and that they can depend on me to perform my best and come to work every day with a positive attitude. They said all my guests love me. So why do they need to keep track of how I feel about the union on their MUD list?

Red Rock workers are fighting for a union contract because we want the favoritism and discrimination to stop.

Thank you.

Hello. My name is Adam Christian. I am employed by Red Rock Resort which is owned by Station Casinos. I work as a server at T-Bones Chophouse and Lounge. I have been there for almost 17 years.

I wear my union button at work. I have been actively organizing at Red Rock for 8-plus years and have been placed on their MUD list as pro-union.

I feel that discrimination from the company is causing me economic harm. Recently, on February 14th, Valentine's Day, management moved me out of the station I was assigned to for the day. Two people took my place in that section for the day, and they served VIP guests in the station that I was supposed to be in. This has happened in the past, always on days when certain VIP guests were placed in my pre-assigned station.

The allegation that Station discriminated against me in table swaps back in 2020 is part of the complaint being heard before the NLRB. I can't wait to testify.

I'm fighting for a contract because I don't want Red Rock to be able do as they wish via favoritism.
