Good morning. Diamante Asberry, here on behalf of the Culinary Union. Employee benefits are vital to the everyday life of gaming workers and their families. And a holder of a Nevada gaming license should not discriminate against employees when it comes to benefits.

we explained to members of the Gaming Commission how Station Casinos discriminates against employees by denying benefits to some while providing benefits to others. Last December, the Culinary Union agreed as the elected representative for a bargaining unit of workers that Station Casinos should give a set of new enhanced benefits to all represented workers at Sunset Station, Green Valley Ranch, and Red Rock Casino. But the Company still has not done the right thing, and has just given the new benefits to non-union workers.

This is not the first time Station Casinos has discriminated against its employees based on their union status.

In 2016, Workers at Boulder Station voted to unionize, and the night the ballots were counted we learned those workers would be subject to company discrimination. What happened was Boulder Station workers' health plan costs were kept at one level while other Station Casinos employees' health plan costs were reduced. How could they do that to families? Why would they subject employees to unequal treatment?

The following year Station Casinos agreed to a settlement related to this matter at Boulder Station. Part of the settlement saw the company agree to the federal government calculating the price tag of Station Casinos' discrimination.

Station Casinos paid just over \$216,000 to make Boulder Station workers whole by providing them with the same reduction in health plan premiums that were granted to employees at its other facilities. The company paid Boulder Station workers for the difference in payments between the higher Boulder Station health plan rate and lower amount paid by employees at other company properties.

Station Casinos discrimination against Boulder Station cost those workers avoidable hardship. The company eventually paid for what they did.

Now Station Casinos is again discriminating against workers at Sunset Station, Green Valley Ranch, and Red Rock Casino, and we ask you to tell them to stop this discrimination and grant benefits to workers on an equal basis. Thank you. Good morning.

My name is Jacobo Jiminez. I worked at Boulder Station as a cook in the buffet for 25 years. I was laid off in 2020.

COVID came and they decided to close the buffet. I thought I would be coming back to work but I never did.

I had to retire. I was not ready to retire at 64. I was going to retire when I was 70, to save up more money. I had to get into my 401k to survive. And now I'm surviving little by little because of social security.

This destroyed the rest of my life. I don't have the savings I planned to have. I don't know why they got rid of me. I want my job back. I am still waiting for the company to call me back to work at Boulder Station.

Please tell Station Casinos to bring workers like me back to work at their old properties.
