PUBLIC COMMENTS AND DISCUSSION:

Comments taken from Member Assad in gratitude of the Investigation Division.

Hello. My name is Diamante Asberry, here on behalf of the Culinary Union.

In September of 2022, Station Casinos' Chief Legal Officer told the North Las Vegas City Council, "We consider ourselves to have been a very solid citizen throughout the pandemic."

In March 2020, Station Casinos buffets closed their doors, and they have no plans to reopen. Workers who relied on steady jobs at these buffets for income have been displaced. In February 2020, an adult allyou-can-eat lunch at Boulder Station's Feast Buffet cost \$13.99. As of October 2022, a single large bone-in wing combo in the Boulder Station food court costs \$16.29.

Station Casinos announced in July 2022 that three neighborhood casinos would be demolished and the land beneath them sold.

Federal Aviation records show a Fertitta private jet flew out of the country the days before a closure announcement and demolitions in the community. A Fertitta private jet flew to England the day before demolition of Texas Station and Fiesta Henderson began. A Fertitta private jet flew to Canada, the day before Station Casinos told employees about the permanent closure of three neighborhood casinos.

Fertitta private jets made an average of over 300 flights per year from 2019 – 2022. The average American takes fewer than 2 round-trip flights a year.

Station Casinos has a huge footprint in this valley and their actions have a wide reach in our community. So we all suffer when they are not held accountable. Hello.

My name is Victoria Camacho. I spoke to you in May.

I worked as a casino porter at Fiesta Henderson for 11 years. Station Casinos laid me off in 2020. I am here again because they have still not called me back to work.

Fiesta Henderson is closed now. I never got my job back. And now the company is building a brand new casino in Durango.

I want the company to pay severance to me and my coworkers who were laid off 3 years ago. They need to respect us and our time with the company.
