PROPOSED AMENDMENTS TO REGULATION 22.1201; PROPOSED NEW REGULATION 22.1202

<u>PURPOSE</u>: To explicitly include Esports within other events; to allow books to accept wagers on Esports events in the manner of traditional sporting events if the books fulfill certain due diligence requirements; to specify the record keeping and notice requirements for books which decide to accept wagers on Esports events; to grant the Board Chair authority to revoke or suspend a book's decision to accept wagers on events conducted by certain Esports event operators; to set out the review process if the Board Chair revokes or suspends a book's decision to accept wagers on events conducted by certain Esports event operators; to explicitly authorize the Board Chair to place Esports event operators on the list of sanctioning organizations; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

Regulation adopted, draft dated January 11, 2023, with amendments as discussed, effective immediately. (Brown voted no)

Good morning. Diamante Asberry, here on behalf of the Culinary Union.

I'm here today to talk to you about what Culinary Union believes is a violation of a federal injunction at Red Rock Casino.

In July 2021, the US District Court in Nevada ordered a rare and extraordinary injunction against Station Casinos' Red Rock Casino. We will turn in a copy of this 34-page injunction along with our comments today.

The injunction prohibits Red Rock Casino from "granting employees benefits to discourage employees from supporting the Union," and "threatening employees with loss of benefits, including lower wages or withholding of benefits they otherwise would have received, unspecified reprisals, or other negative consequences if they select the Union."

In December 2022, Station Casinos informed the Culinary Union of its new enhanced benefits program. We agreed that Station Casinos COULD and SHOULD give these enhanced benefits to all workers we represent. But in January of this year, Station Casinos rolled out the new benefits to non-union workers, and didn't provide them to unionized workers at Red Rock and other properties. It announced that workers represented by the union are not eligible because of the company's legal obligation to bargain with over the benefits. But we ALREADY TOLD Station Casinos that it could give these benefits to represented workers without objection from us. It could have done so months ago. It continues to deny unionized workers these enhanced benefits.

Meanwhile, Station Casinos congratulated its slot technicians at Sunset Station after the company withdrew recognition from their union in May. When it did so, it announced that the slot technicians now get the enhanced benefits because Station no longer has to bargain with their union. It's clear to us that Station Casinos is using these benefits to undermine employers' support for a union. Once again.

The injunction currently in place at Red Rock Casino extends not only to Red Rock but to the entities and corporate officials who are in privity to it or responsible for its actions.

If we're right that Station Casinos is using benefits to discriminate against unionization, then the federal court could find Red Rock Casino and those responsible for its actions in contempt if the National Labor Relations Board were to bring such a petition.

We will keep you updated on all developments on this matter.

### **Public Comment**

Good morning. [name] for the Culinary Union. A gaming license holder like Paris Casino is a landlord with third party tenants. Paris Casino as the landlord and gaming license holder is required by Nevada law to ensure third party tenants follow rules, regulations and laws. Workers in third party restaurants need the landlord to hold restaurant tenants accountable.

Casino licensees are responsible for the conduct of their tenants and accountability to adhere to rules, regulations, and laws according to NRS 463.0129 and GBC 5.010.<sup>1</sup> This includes misconduct that falls under the enforcement of the Gaming Control Board (GBC 5.011).<sup>2</sup>

Example 1: Water on the floor inside a kitchen area. On August 16, 2023, a kitchen area where Alexxa's Kitchen and Bar workers are present had water on the floor. Alexxa's is a restaurant by JRS Hospitality. In a video,<sup>3</sup> we saw multiple workers standing in water as well as wet cardboard. While workers were cleaning up, meal prep continued in the area: employees were active in the area where water was.

Example 2: Fire. On May 10, 2023, the Fire Department was called inside Paris due to a fire in the third-party restaurant Alexxa's Kitchen and Bar. In their report, the Clark County Fire Department stated: "It appears hot oil was spilt or dripped down the side and caught a towel on fire that was under the fryer as well as the electrical wire for the fryer." Caesars is responsible as the landlord to make sure that Alexxa's follows OSHA standards and keeps all individuals on the property safe.

Example 3: Violence towards customers and employees. In December 2021, an employee was stabbed at Paris Hotel and Casino, near Mon Ami Gabi<sup>6</sup>, a Lettuce Entertain You restaurant. The incident from the LV Metropolitan Police Department states:

The male followed the victim to the bathroom and stabbed one of the bathroom doors and asked the victim "Whats up with you" and then the suspect told the victim to get on his knees. The suspect swung the knife at him and he leaned forward to avoid getting hit by the neck, and he got cut above the left eyebrow instead. The victim then grabbed the knife with his right hand and elbowed the suspect with his left elbow to defend himself.<sup>7</sup>

Before this attack, the male had followed a female employee into Paris and spent time in a kitchen. According to the police, the person was able to enter Caesars' property by raising his hand when seeing the security officer and he "simulated scanning his badge."

On July 4, 2022, asserting to the police report, an individual "approach and outcomes sitting."

On July 4, 2022, according to the police report, an individual "approach[ed] customers sitting on the stairs outside of the restaurant and spit on them." It continued:

The male then walked away and walked back and hopped over the barrier to enter the restaurant and scratched [redacted] in the back of his neck causing [redacted] to punch him in the face. Williams then picked up a butter knife off of the table and stated, "I'm going to fucking kill you" and charged at [redacted]."<sup>10</sup>

Public confidence and trust are key to the success of gaming establishments. Employees, customers and all of us in Las Vegas need to be able to trust Caesars Entertainment and Paris Casino as the landlord for restaurant tenants to ensure safe conditions at all of their properties.
