


NEVADA = ESPORTS

POTENTIAL CAVEATS OR BARRIERS

- Video Game Publishers & Developers Must Be Included - Represented due to Potential Impact to their IP.
- Expansion of Integrity Standards to Include eSports (ESIC).
- University is should serve as venue for discussions and funnel for research of shared ideas.or new knowledge.
- Community & Academic Resources & Reports should expand to advise Regulators of Benefits/ Risks of rapidly emerging data/technologies/ methods/policy.



INCLIDING ESPORTS PUBLISHERS/DEVELOPERS - REASONS

- ► Their IP is the sport. Any standardizationa or potential impacts to playability must be jointly evaluated and decided.
- Value to Determine Integrity: Tournaments and Fair Outcomes are Mutual Goals
- Operations to ensure integrity are key to their success and ours
- ▶ Benefit of bringing them to Nevada Promotes Expansiln of Operations to he state.
- Define Mutual Standards for Self-Enforcement, Self-Regulating
- ► Keep open communications promote transparency and apply our resources to their success which ensures ours.

EXPAND AND EVOLVE INTEGRITY GUIDELINES

- eSports Medium is almost entirely digital, invites digital threats
- ► Test and innovate on technological threats by including best minds and ideas to be ahead of manipulation innovate early and often.
- Promote technological integrity guidelines for hardware and software used in competition play - ESIC guidelines are a great starting point.
- Share solutions with publishers, vendors & stakeholders
- Establish Nevada as global example of broad minded and gold-standard in eSports as well as existing High Standards and Integrity in Global Gaming Community
