RE: INTERNAL CONTROL PROCEDURES – RELEASE OF ADDITIONAL PROPOSED REVISIONS

On April 23, 2004, the Gaming Control Board distributed to all Group II nonrestricted licensees proposed revisions to the Internal Control Procedures (ICPs). Following the distribution of these materials, the Board received and reviewed oral and written comments submitted by licensees and other interested parties. Based on the comments received, the Board made additional changes to the proposed ICPs. The "Revisions to the Proposed Internal Control Procedures dated April 15, 2004" contain such changes. This schedule can be obtained from the Board's website at http://gaming.nv.gov/. They can also be obtained on floppy disk or hard copy at either the Carson City or Las Vegas Tax and License Division offices. The proposed changes are denoted with lines through the deletions and the underlining/bolding of the additions.

The proposed ICP changes and revisions are again being noticed for comments in accordance with Regulation 6.100(2). Please note a copy of Regulation 6.100, that includes a description of the ICP adoption process, was previously provided in that letter dated April 23, 2004, pursuant to Regulation 6.100(2) (b). The Board encourages the submission of written comments, concerns or suggestions regarding the proposed ICP revisions. These comments should be received by the Board no later than September 17, 2004.

If your objections or concerns with a particular ICP are unique to your operation and would not benefit all Group II licensees, please consider the provisions of Regulation 6.100(7). This paragraph of the regulation allows a licensee to seek the Board Chairman's approval of variations from the ICPs when a licensee's alternative procedures satisfy the objectives of internal control described in Regulation 6.100(1).

Due to the ongoing nature of the ICP revision process, it is recommended that you periodically check the Board's website for new developments and information.
