PROPOSED AMENDMENTS TO EXISTING REGULATIONS**

The State Gaming Control Board has scheduled a public workshop on October 25, 2005, at 1:00 p.m. in Conference Room 2450, 555 East Washington Avenue, Las Vegas Nevada, to discuss proposed new regulations and proposed amendments to existing regulations as follows:

NGC REGULATION 1 "ISSUANCE OF REGULATIONS: CONSTRUCTION; DEFINITIONS,"
specifically **PROPOSED NEW NGC REGULATION 1.067, "CONSUMER LOAN" DEFINED.**

NGC REGULATION 3 "LICENSING QUALIFICATIONS," specifically **NGC REGULATION 3.050(2), "FINANCIAL REQUIREMENTS."**

NGC REGULATION 3 "LICENSING QUALIFICATIONS," specifically **NGC REGULATION 3.100, "EMPLOYEE REPORT."**

NGC REGULATION 4 "APPLICATIONS: PROCEDURE," specifically **NGC REGULATION 4.030, "CLASSIFICATION OF LICENSES, AND OTHER COMMISSION ACTIONS FOR WHICH APPLICATIONS MUST BE MADE."**

NGC REGULATION 5 "OPERATION OF GAMING ESTABLISHMENTS," specifically **PROPOSED NEW NGC REGULATION 5.016, "GRANTING OF CONSUMER LOAN PROHIBITED."**

NGC REGULATION 5 "OPERATION OF GAMING ESTABLISHMENTS," specifically **PROPOSED NEW NGC REGULATION 5.210, "AUTHORIZING THE IMPOSITION OF A FEE FOR ADMISSION TO AN AREA IN WHICH GAMING IS CONDUCTED."**

NGC REGULATION 5 "OPERATION OF GAMING ESTABLISHMENTS," specifically **PROPOSED NEW NGC REGULATION 5.220, "OPERATION OF A MOBILE GAMING SYSTEM."**

NGC REGULATION 6 "ACCOUNTING REGULATIONS," specifically **NGC REGULATION 6.105, "INTERNAL CONTROL FOR OPERATORS OF INTER-CASINO LINKED SYSTEMS AND MOBILE GAMING SYSTEMS."**

NGC REGULATION 6 “ACCOUNTING REGULATIONS,” specifically PROPOSED NEW NGC REGULATION 6.118, “MANDATORY DISCLOSURE PROVISIONS FOR CREDIT APPLICATIONS AND CREDIT INSTRUMENTS.”

NGC REGULATION 8 “TRANSFERS OF OWNERSHIP: LOANS,” specifically NGC REGULATION 8.130, “TRANSACTION REPORTS.”

NGC REGULATION 14 “MANUFACTURERS, DISTRIBUTORS, OPERATORS OF INTER-CASINO LINKED SYSTEMS, GAMING DEVICES, INTER-CASINO LINKED SYSTEMS, ON-LINE SLOT METERING SYSTEMS, CASHLESS WAGERING SYSTEMS AND ASSOCIATED EQUIPMENT,” specifically NGC REGULATION 14.010, “DEFINITIONS.”

NGC REGULATION 14 “MANUFACTURERS, DISTRIBUTORS, OPERATORS OF INTER-CASINO LINKED SYSTEMS, GAMING DEVICES, INTER-CASINO LINKED SYSTEMS, ON-LINE SLOT METERING SYSTEMS, CASHLESS WAGERING SYSTEMS AND ASSOCIATED EQUIPMENT,” specifically NGC REGULATION 14.030, “APPROVAL OF GAMING DEVICES AND THE OPERATION OF NEW INTER-CASINO LINKED SYSTEMS; APPLICATIONS AND PROCEDURES.”

NGC REGULATION 14 “MANUFACTURERS, DISTRIBUTORS, OPERATORS OF INTER-CASINO LINKED SYSTEMS, GAMING DEVICES, INTER-CASINO LINKED SYSTEMS, ON-LINE SLOT METERING SYSTEMS, CASHLESS WAGERING SYSTEMS AND ASSOCIATED EQUIPMENT,” specifically NGC REGULATION 14.080, “FIELD TEST OF NEW GAMING DEVICES AND NEW INTER-CASINO LINKED SYSTEMS.”

NGC REGULATION 22 “RACE BOOKS AND SPORTS POOLS,” specifically NGC REGULATION 22.135, “USE OF COMMUNICATION DEVICES PROHIBITED.”
