**SUBJECT: WORKSHOP FOR PROPOSED CHANGES TO FIELD TRIAL TESTING OF  
CERTAIN ASSOCIATED EQUIPMENT**

The State Gaming Control Board has proposed revisions to the process for approving new Associated Equipment, the installation of such new Associated Equipment and modifications to existing Associated Equipment (collectively, "AE Proposals").

The Board will be presenting the details of such AE Proposals at an industry workshop in order to garner industry comments. The meeting will be held in the Las Vegas Gaming Control Board Hearing Room on November 29, 2005, at 9:00 a.m.

Briefly, the AE Proposals are designed to provide better communication between the Gaming Control Board and industry and to expedite the approval process for Associated Equipment. The following are a few of the AE Proposals which will be further detailed at the industry meeting:

- Revised definitions of new and/or modifications to Associated Equipment
- For each form of Associated Equipment, providing the specific requirements under the applicable Statutes, Regulations, Minimum Internal Control Standards, Technical Standards and reports
- Stated/Targeted turn around times for approvals
- No field trial requirements for installation or previously approved Associated Equipment at each casino location
- Executive sign-off (e.g. Sarbanes-Oxley Act or NGC Reg. 14.090) on the initial submission for Associated Equipment providing the system meets the various requirements
- Establishment of a single point of contact for both Gaming Control Board and manufacturer
