SUBJECT: ADOPTION OF AMENDMENTS TO REGULATION 6.150 AND

REVISED BANKROLL FORMULA

The Nevada Gaming Commission adopted a revised bankroll formula on February 23, 2006. It also adopted revisions to Regulation 6.150 on March 23, 2006. To provide licensees with sufficient time to bring their bankroll amounts and computational procedures into compliance, a compliance date of June 26, 2006 has been established.

A bankroll formula information page is available on the Board's website at http://gaming.nv.gov/bankroll_formula.htm. The regulation, formula and instructions are all available on that page.

As is noted in the instructions for the formula and Regulation 6.150, certain waivers may be available. All requests by Group I licensees for waivers must be received by the Audit Division no later than May 5, 2006 to permit the Board to consider the waiver request prior to the compliance date. Waiver requests by all other licensees are to be received by the Tax and License Division, also by May 5.

To assist both the Board and licensees with the identification of potential compliance issues, each <u>Group I</u> nonrestricted licensee is to submit a completed bankroll worksheet for May 2006 no later than June 16, 2006. Regulation 6.150(6) requires monthly computations of the bankroll requirements. Licensees may select any day in May to use for this purpose, and the day selected should be properly identified in the submission.

Revisions to Regulation 6.150 and Bankroll Formula Page 2
