**NOTICE OF HEARING FOR ADOPTION OF AMENDMENTS TO REGULATION OF  
THE NEVADA GAMING COMMISSION AND STATE GAMING CONTROL BOARD**

The Nevada Gaming Commission will hold a public hearing on or about the hour of 9:30 a.m. on December 21, 2006, in Conference Room 100, 1919 College Parkway, Carson City, Nevada for the purpose of considering adoption of the following proposed regulation amendments:

- **NGC REGULATION 5.200, "LICENSING AND OPERATION OF AN INTERNATIONAL GAMING SALON."**

Purpose of Amendments: To remove any references to NGC Regulation 6A due to its repeal; to update the logging requirements and related record retention for international gaming salons; to take such additional action as may be necessary and proper to effectuate these stated purposes.

- **NGC REGULATION 6.090, "INTERNAL CONTROL FOR GROUP I LICENSEES."**

Purpose of Amendments: To remove any references to NGC Regulation 6A due to its repeal; to take such additional action as may be necessary and proper to effectuate this stated purpose.

- **NGC REGULATION 22, SPECIFICALLY 22.010, "DEFINITIONS," 22.060, "ACCEPTANCE OF WAGERS," 22.061, "NONCASH WAGERS IN EXCESS OF \$10,000," 22.062, "MULTIPLE WAGERS," and 22.064, "REQUIRED SUBMISSIONS TO THE BOARD."**

Purpose of Amendments: To remove any references to NGC Regulation 6A due to its repeal; to revise the reporting of race and sports book noncash, nonpari-mutuel wagers in excess of \$10,000 so as to require the reporting of all nonpari-mutuel wagers over \$10,000 regardless if the wagers were noncash or cash; to delete provisions that would require duplicate reporting under the amendments to this regulation; to take such additional action as may be necessary and proper to effectuate these stated purposes.

- **NGC REGULATION 26C.071, "REQUIRED SUBMISSIONS TO THE BOARD."**


**Purpose of Amendments:** To remove any references to NGC Regulation 6A due to its repeal; to delete provisions that would require duplicate reporting under the amendments to this regulation and the concurrent amendments to Regulation 22; to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed amendments will be considered by the Commission in accordance with the provisions of NRS 463.145 which allows that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally.

In addition, these regulation amendments are agendaed for discussion at the Nevada Gaming Commission meeting on November 16, 2006, in Conference Room 2450, 555 East Washington Avenue, Las Vegas, Nevada, on or about the hour of 9:30 a.m.
