RE: PROPOSED MINIMUM INTERNAL CONTROL STANDARDS RELATING TO SYSTEM BASED GAMES, SYSTEM SUPPORTED GAMES AND MOBILE GAMING SYSTEMS

The State Gaming Control Board (Board) has drafted proposed revisions to Minimum Internal Control Standards (MICS), which are dated August 14, 2007 and are on the Board's website at <http://gaming.nv.gov>.

These proposed MICS are specific to the use of a mobile gaming system (MGS), system based games (SBG) and/or system supported games (SSG) in the slots department.

These proposed MICS revisions along with proposed Technical Standards changes for SBG, SSG and MGS will be discussed at a Board public workshop on August 28, 2007 at 10:00 a.m. in the Gaming Control Board Las Vegas hearing room.

As indicated in the Board's letter, dated July 12, 2007, comments during the public workshop will be considered in making revisions to these proposed MICS and Technical Standards. After final revisions to these draft MICS, the MICS will become finalized and codified in a policy letter, which will indicate the standards to be used with MGS, SBG and SSG and the procedures to include in the written system of internal control to comply with the proposed MICS for licensees operating MGS, SBG and/or SSG. Such policy letter will be issued in October 2007 and will be effective until the MICS are formally amended in 2008.
