RE: ADOPTION OF REVISED INTERNAL CONTROL PROCEDURES

On September 23, 2004, version 3 of the Internal Control Procedures (ICPs) was adopted with an effective date of January 1, 2005. The changes made represented a direct correlation to the technical advances that have occurred within the industry since October 5, 1995. Since the last revision, Tax and License Division personnel have had an opportunity to review the internal control procedures at all Group II licensees. After our internal review and discussions with industry representatives, it was decided that the proposed revisions to the internal control procedures were in order. Most of the changes consist of a reduction or elimination of specific controls.

The new version of the ICPs will be labeled version 3.1. The sections of the adopted ICPs can be obtained from the Board's website at <a href="http://gaming.nv.gov.">http://gaming.nv.gov.</a>
They can also be obtained at either the Carson City or Las Vegas Tax and License Division offices. At this time no changes were made to the ICPs for Live Entertainment, Bingo, Keno, Race and Sports Books and Pari-Mutuel.

The proposed ICP changes are being noticed for comments in accordance with Regulation 6.100(2). Attached is a copy of Regulation 6.100 that includes a description of the ICP adoption process, and is being provided pursuant to Regulation 6.100(2)(b). The Board encourages the submission of written comments, which should be received by the Board no later than June 20, 2008.
