RE: LAB INVESTIGATIVE FEE ACCOUNT BALANCES

It is the policy of the State Gaming Control Board that all applicants who submit items to the Technology Lab for review and approval must maintain, at all times, a positive account balance with the lab. Those parties who have larger projects or anticipate making regular submissions should plan for regular deposits to maintain positive balances. Not doing so may lead to the suspension of review, rejection, or disapproval of submitted items.

In accordance with NRS 353.1467, all payments of money owed to a state agency for taxes, interest, penalties or any other obligations that, in the aggregate, amount to \$10,000 or more must be made by any method of electronic transfer of money allowed by the state agency. The method allowed by the State Gaming Control Board is the ACH CCD + format for US applicants. The method allowed by the State Gaming Control Board is a standard wire transfer for international applicants.
