**SUBJECT: REQUIREMENTS FOR INSTALLATION OF SYSTEM BASED,
SYSTEM SUPPORTED, AND MOBILE GAMING SYSTEMS**

The Gaming Control Board Technology Division has published new forms outlining the requirements for an operator requesting installation of system based, system supported or mobile gaming systems.

The operation of system based, system supported and mobile gaming systems is dependent on how the system is implemented at each licensed gaming establishment. This is due to factors such as the location's structural layout and network infrastructure, staffing availability, and internal controls. To ensure the integrity of these systems in the field, it is necessary for the Technology Division to evaluate and inspect each installation in Nevada prior to deployment.

System Based, System Supported, and Mobile Gaming System Installation
Request Submission Requirements

INTRODUCTION

This document outlines the submission requirements for requesting installation of a system based, system supported, or mobile gaming system. The Technology Division will be responsible for the review and inspection of all such requests. A complete installation request will require completion and submission of all necessary forms and materials outlined in this document. Following the review of all submitted materials, the Technology Division will inspect the installed system at the licensed gaming establishment before the system is made available for play. The review and inspection process will take approximately 30 days from the receipt of a complete installation request. The operator of the mobile gaming system (as defined in Regulation 5.220(1)(h)) seeking approval of the installation of the system must pay the cost of the inspection and investigation. Additionally, the operator of the mobile gaming system is responsible for paying the cost of any future system inspections intended to verify the continued operation of the system as represented during the installation inspection and investigation process.

All submission items described in this document must be submitted in digital format.

REQUIRED FORMS

Completed User's Request for Installation of a System Based, System Supported, or Mobile Gaming System.

REQUIRED SUBMISSION MATERIALS

1. A network diagram that identifies all components on the network including but not limited to EGMs, servers, socket IDs, switches, routers, access points, remote logging devices and security devices.
2. A listing of all applicable security settings such as firewall rules and configurations, router ACLs, group policies, etc.

3. A user access listing that identifies all user roles and their level of access to the gaming device as well as a description on how system administrator level access is achieved on the system portion of the device.
4. A floor map of the installation location that identifies all applicable surveillance coverage necessary to comply with Technical Standard 1.050(3)(b). If any gaming device in the installation request offers a payout of more than \$250,000, the map shall also identify surveillance coverage necessary to comply with all applicable surveillance standards.
5. A copy of all applicable internal controls for operation of the system based, system supported, or mobile gaming system.

ADDITIONAL SUBMISSION MATERIALS FOR MOBILE GAMING SYSTEMS

1. A floor map of the installation location that identifies the intended wireless gaming area and identifies the locations of all devices used in restricting gaming operation of mobile communication devices to approved gaming areas. This map shall also identify locations of all terminals used to reconcile gaming activities in case of mobile device failure or game disputes.
2. A copy of the contract or agreement between the operator of the mobile gaming system and licensed gaming establishment that identifies which portions of the mobile gaming system will be operated by each party if the licensed gaming establishment is not the sole operator of the mobile gaming system.
3. A wireless heat map or site survey that illustrates wireless signal strength and coverage on the gaming floor.
4. Copies of all information intended to inform patrons about mobile gaming operation such as gaming area maps, rules of operation, and how to operate mobile devices.
