II. WORKSHOP AGENDA

PROPOSED AMENDMENTS TO REGULATION 22.120, 22.140, and 22.145

Purpose: To allow books to accept event wagering on events other than a horse race, greyhound race, or an athletic sports event; to specify requirements for book wagering communications with other books; to change out of state patron wagering requirements in line with current technological capabilities; to allow books to open wagering accounts at locations outside of their premises; to allow books to accept in race wagering; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
