***PURPOSE:** To amend provisions of Regulation 14 and specifically, 14.010(6), **14.010(7)** 14.010(14), 14.170, 14.180 and 14.190 **and add 14.010(17)** to conform to the Nevada Gaming Control Act as amended by Assembly Bill 294 of the Seventy-Sixth Regular Session of the Nevada Legislature; providing for applications, recordkeeping and procedures for extraterritorial distribution of gaming devices based on operational differences in licensees; clarifying requirements for distribution by licensees other than manufacturers and distributors licensed by the commission; and providing other matters properly related thereto.
