SUBJECT:

Regulations 6.010 and 6.080 – Posting of Annual Threshold Amounts for Group I and II Nonrestricted Licensee Definitions and for Submission of Audited/Reviewed Financial Statements

Pursuant to NRS 463.159(3) and Regulation 6.080(2), (3) and (4), the Board is required to adjust the annual threshold amounts used to determine which nonrestricted licensees are subject to audits of financial statements and which are subject to reviews of financial statements. Additionally, pursuant to Regulation 6.010(7), the Board is required to adjust the annual gross revenue threshold amounts defining Group I and Group II nonrestricted licensees. The annual threshold adjustments mentioned above are required to be posted on the Board's website no later than December 15 preceding the fiscal year for which such amounts shall be effective.

The threshold amounts indicated in the below table are for Regulations 6.010 and 6.080 and have been calculated based on a consumer price index ("CPI") adjustment of 1.4%. The revisions to Regulation 6.080 will be effective January 1, 2015, while the changes to Regulation 6.010 will be effective July 1, 2015.
