PROPOSED AMENDMENT, ADDITION, AND/OR DELETION TO REGULATION 5:

PURPOSE: To define and establish "authorized players" in the context of mobile gaming; to allow patrons to remotely open a mobile gaming wagering account; to revise the procedures for patrons to open mobile gaming wagering accounts; to establish procedures for maintaining the accuracy of the information associated with a mobile gaming wagering account; to expand the scope of what qualifies as a service provider and who must be licensed as a service provider; and to take such additional action as may be necessary and proper to effectuate these state purposes.

PROPOSED AMENDMENT, ADDITION, AND/OR DELETION TO REGULATION 22:

PURPOSE: To define and establish "authorized players" in the context of race books and sports pools; to authorize a book to withhold payment of a wager to a patron if the patron does not provide identification and other documentation required by state or federal law; to require betting tickets to state the identification and documentation necessary to redeem the ticket; to set out betting tickets presented by mail must include identification and documentation as required by state or federal law; to allow patrons to remotely open a sports pool or race book wagering account; to revise the procedures for patrons to open sports pool or race book wagering account; to revise procedures for maintaining the accuracy of the information associated with a sports pool or race book wagering account; to set out circumstances in which a sports pool or race book may not close a wagering account; to expand the entities and circumstances where a sports pool or race book may share certain information regarding a patron; and to take such additional action as may be necessary and proper to effectuate these state purposes.

PROPOSED AMENDMENT, ADDITION, AND/OR DELETION TO REGULATIONS 26C:

PURPOSE: To revise the procedures for patrons to open off-track pari-mutuel horse wagering accounts; to revise procedures for maintaining the accuracy of the information associated with an off-track pari-mutuel horse wagering account; to establish procedures through which books may use account wagering to lay off bets with a pari-mutuel book; to set out circumstances in which a book may not close a wagering account; to expand the entities and circumstances where a pari-mutuel book may share certain information regarding a patron; and to take such additional action as may be necessary and proper to effectuate these state purposes.
